Specific objectives	<ul style="list-style-type: none"> • Learning the adequately language for EU law subject. • Understanding the evolution of the European structure taking into account the extension of the institutional framework, the competences, organization and functioning of each institution of the EU • Learning the principles and the fundamental concepts of EU law which represent the basic terms for all those working in economic field • Using the juridical knowledge acquired in order to understand the decisions of the European institutions within the global context of European internal market. • Learning about the jurisprudence of the Court of Justice of the European Union, especially about those cases that have established the fundamental principles on which the functioning of the European institutions and of the European Union itself are based on. • Developing the capacity to analyze and to use the jurisprudence of the Court of Justice of the EU as a tool within their future economic career. • Developing the capacity to understand texts from legal publications or mass-media news regarding the contemporary process of EU development and its impact on the member states, European citizens or companies. • Developing personal skills for an efficient use of EU law concepts, principles or jurisprudence in atypical situations of individual impact as an addressee of EU rules. • Developing the individual capacity to manage his/her own arguments supporting an idea and to take into considerations other points of view. • Developing the individual capacity to analyze and to synthesize the legal knowledge acquired. • Developing the individual capacity to work individually or in a team with the capacity to identify solutions for specific legal issues occurred through the day to day economic activities. • Increasing the level of individual legal culture, which is necessary for a future professional development. • Applying the principles, the rules and the values of professional ethics in the own efficient and responsible work strategy
