7.1. General objective	The Business Law course aims to familiarize the economics student with the fundamental legal concepts of business organization and operation, to learn the legal language and to master the legal principles governing the business environment. The student acquires the necessary knowledge to use the legislation applicable to commercial operators. Skills are developed in concluding contracts and monitoring the way they are carried out.
7.2. Specific objectives	Knowledge of notions and concepts specific to business law and understanding of the mechanisms regulating business relationships; deepening of the complex structure of legal relationships established within the business environment. Appropriate use of the fundamental concepts and principles of business law in the decision-making process, in solving the various problems faced by economic operators. Carrying out comparative analyses between the various legal and economic institutions specific to the business environment.
